OVERVIEW

Boomer leagues, tournaments and shootouts are open to all teams that are looking to play competitive basketball from October 2019 thru March 2020. Boys & Girls in the 3rd thru 8th grade (2019-20 school year) shall be eligible to play in their respective divisions.

Two JCC approved referees shall be assigned to every game by an assignor.

LOCATION

LEAGUE FORMAT

The Boomer **Fall League** and **Spring League** will play Sunday afternoon double headers. Tournament play will be through the week (mon, tue & thur)

TOURNAMENT FORMAT

One day tournaments all on Saturday - 3 Game Guarantee

SHOOTOUT FORMAT

One day tournaments all on Sundays- 2 Game Guarantee

FEES

Each **League** = \$100 per team (due 2 weeks before date of play)

Each **Tournament** = \$200 per team (due 2 weeks before date of play)

Multi-Tourney Team Discount = 2 tournaments for \$175/team or 3 tournaments for \$150/team. Must be paid in full prior to the first tournament participated in to qualify for the Multi-Tourney Team Discount.

Each **Shootout** = Teams only pay referee costs

Teams are required to provide a scorekeeper for each tournament, league and shootout game. 2 Coaches and a scorekeeper for each team will receive free admission. All others will be required to pay the standard admission fee.
